**TABLED MATTERS**

- 1. GOLF TEE PAD SITE AND BRUSTER'S** - located at 1039 Ridge Road. The applicant, Ridge Road Golf LLC., is requesting **PRELIMINARY / FINAL SITE and SUBDIVISION PLAN APPROVAL PUBLIC HEARING** to subdivide 9.6 acre parcel (SBL# 079.15-1-08.11) into 3 commercial lots. The construction of a 8,000 square foot medical building on proposed Lot #R-1, having 1.289 acres and lot #R-2, comprised of 1.082 acres to be utilized by the existing Bruster's Site. The proposal to be located in an MC District (Medium Commercial) under Sections 192- 17 &18; and 228-5& 8 of the Code of the Town of Webster. **Approved revised Preliminary & Site Plan with conditions**

- 1. ALDI'S ADDITION –** Located at 915 Ridge Road. Applicant, ALDI Inc., is requesting **PRELIMINARY SITE PLAN APPROVAL** to construct an 336.0 square foot addition of a Cooler/freezer and remodel of the building canopy on 2.8 acres of land having SBL numbers 079.15-1-30.1, located in an MC District (Medium Commercial) under Section 228-5 of the Code of the Town of Webster. **Approved**
  
- 2. 1775 TEBOR ROAD –** Located north of 700 Basket Road at the southeast corner Tebor Road and Basket Road intersection. Applicant Roman Melnik, is requesting **PRELIMINARY SITE PLAN APPROVAL / PUBLIC HEARING AND PHASE ONE FINAL SITE PLAN APPROVAL** to develop a phased project construct two 21,000 square foot buildings. The initial phase consisting of a 10,500 trucking terminal building with associated parking on a 4.67-acre parcel of land having parcel number 068.03-01-24.12. Located in a IN District( Industrial Zoning District)Under Section 228-5 and 8 of the Code of the Town of Webster. **Approved**
