- 1. GERRITZ SUBDIVISION** – Located at 1042 Klem Road, Applicant, and Peter Gerritz is requesting a **PRELIMINARY / FINAL APPROVAL / PUBLIC HEARING** to subdivide the existing 2.6 acre Parcel SBL# 064.16-1-1, into 3 single family lots located in an R-2 District (Single Family) under Sections 192-17 and 18 of the code of the Town of Webster.

- 1. 370 WEBSTER ROAD ACCESSORY BUILDING** – located at 370 Webster Road. Applicant, Thomas J Busch, is requesting **PRELIMINARY /FINAL APPROVAL / PUBLIC HEARING** to construct 40 X 30 (3 stall garage) accessory building on a 1.7.0 acre parcel having SBL# 0050.03-2-6 located in an R-1 District (Single Family) under Section 225-36 of the Code of the Town of Webster.

- 2. WEBSTER PLAZA OUTBUILDING AND LIBRARY ENTRANCE-** - Located at 980 Ridge Road, Applicant B.A.G. Investments, INC. is requesting an **ONE YEAR EXTENSION OF FINAL SITE APPROVALS / PUBLIC HEARING** to reconfigure the library and library entrance, as well as the construction of two out-buildings.
