### Public Hearing:

**TABLED ITEM:** To consider enacting a Local Law amending the Zoning Law of the Town of Webster (Chapter 225) by adding thereto, as a permitted use within LC Class II Low Intensity Commercial District, “Mini Storage” or “Self Storage”, facility.

### Regular Town Business:

1. Consideration to approve purchase orders, bills, prepaid warrant, transfers and budget amendments as submitted by the Director of Finance.
2. Resolution to declare the following item as surplus for trade-in from the Webster Police Department: 2007 Chevrolet Impala, VIN #2G1WS55RX79372592, Asset # 4641.
3. Resolution to consider taking permanent dedication of Halesworth Lane within the Town of Webster.
4. Resolution to authorize the Supervisor to sign an agreement between the Town of Webster and Lifespan for 2016.
5. Resolution to establish the Town Board as lead agency for the 2016 Security, Safety and Facility Enhancement Project.
6. Resolution to approve the environmental review for the 2016 Security, Safety and Facility Enhancement Project.

7. Bond Resolution authorizing the Town of Webster to undertake the renovation, alteration and improvements to the Justice Court Building and construction of a new Maintenance Building and Restroom Facilities for the Parks and Recreation Department, with the maximum estimated cost of \$1,300,000, and authorizing the issuance of up to \$1,300,000 in serial bonds.
8. Bond Resolution to authorize the Town of Webster to undertake the acquisition of equipment for use by the Town of Webster Highway Department, with the maximum estimated cost of \$575,000, and authorizing the issuance of up to \$575,000 in serial bonds.
9. Bond Resolution to authorize the Town of Webster to undertake the construction and installation of improvements at the Town Recreation Center, with the maximum estimated cost of \$225,000, and authorizing the issuance of up to \$225,000 in serial bonds.
10. Bond Resolution to authorize the Town of Webster to undertake the renovations, alterations and improvements to the Town Hall/Police Department Building and the Highway Garage, with the maximum estimated cost of \$1,800,000, and authorizing the issuance of up to \$1,800,000 in serial bonds.
