Regular Town Business:

1. Consideration to approve purchase orders, bills, transfers and budget amendments, as submitted by the Director of Finance.
2. Resolution to approve Pay Application #1 for Ledge Creek Development in the amount of \$30,888.00.
3. Resolution to authorize the Supervisor to sign a Lease and Maintenance Agreement for a Xerox Work Centre copier for the Department of Public Works.
4. Resolution to authorize the Supervisor to sign a Maintenance Agreement with Central Business Systems for a Minolta 350 Copier for records storage through the Town Clerk's Office.
5. Resolution to authorize the Supervisor to sign a contract with Systems Development Group, Inc. for computer software support services for the Office of the Assessor.
6. Resolution to approve the Highway Jurisdictional Transfer from the State of New York to the County of Monroe for Lake Road from the Irondequoit Bay Outlet Bridge to NYS Route 250 (this will support removing the speed ordinance in Chapter 210:22 of the Town Code of the Town of Webster).
7. Resolution to approve Pay Application #1 for Concord Electric Corp. for the Recreation Center Project in the amount of \$12,350.00

8. Resolution to authorize the Supervisor to sign an agreement with Penn Power Systems for the emergency generator set planned maintenance agreement at the Webster Wastewater Treatment Plant, for the period of January 1, 2011 through December 31, 2012.
9. Resolution to consent to the placement of traffic control devices by the Monroe County Department of Transportation, pursuant to the authority granted by Sections 1651 & 1652-a of the NYS Vehicle & Traffic Law, at the following locations:
 - To post Center Lane Must Turn Left/Northbound & Southbound – Phillips Road 405 ft. north of Orchard Street/San Jose Drive and Halifax Drive, Webster, New York.
 - To post Center Lane Must Turn Left/Northbound & Southbound – Phillips Road 395 ft. north of Mitcheldean Drive to Ebina Drive, Webster, New York.
10. The Town Board will adjourn in to Executive Session to discuss a personnel issue.
