- 1) To consider acting on a Home Rule to abandon the pioneer cemetery, know as the Robb Cemetery, and convey its interest in such real property to the Village of Webster.

Regular Town Business:

1. Consideration to approve purchase orders, bills, prepaid warrant, transfers and budget amendments as submitted by the Director of Finance.
2. Resolution to authorize the Supervisor to sign a Home Rule to abandon the pioneer cemetery, know as the Robb Cemetery, and convey its interest in such real property to the Village of Webster.
3. Resolution to authorize, effective December 31, 2012, a transfer of \$325.31 from the General Town-wide fund to close the three projects listed below:
 - H0111 Records Storage
 - H0118 Youth Sports Facilities
 - H0130 Highway Salt BarnThese projects had residual balances that needed to be combined and cleaned up to close.
4. Resolution to authorize the closing of three completed capital projects, effective December 31, 2012, with unexpended debt proceeds and interest earnings, and transfer the monies to the Debt Service Fund to be utilized in future years to reduce the debt payments made by the source funds, as follows:
